



## PATIENT INFORMATION ON DATA PROTECTION

Dear patient,

The protection of your personal data is important to me. According to the EU General Data Protection Regulation (GDPR), I am obliged to inform you about the purpose for which my practice collects, stores or forwards data. The information you can also see which rights you have in terms of data protection.

### RESPONSIBILITY FOR DATA PROCESSING:

### 2. PURPOSE OF DATA PROCESSING:

The data processing takes place on the basis of legal requirements in order to terminate the treatment contract between you and your doctor (Dr. med. Andreas Ritter) and to fulfill the associated duties.

For this purpose, I process your personal data, in particular your health data. This includes medical history, diagnoses, therapy suggestions and findings that I or other doctors collect. For these purposes, other doctors or psychotherapists with whom you are being treated can also provide me with data (e.g. in doctor's letters).

The collection of health data is a prerequisite for your treatment. If the necessary information is not provided, careful treatment cannot be carried out.

### 3. RECIPIENT OF YOUR DATA:

I will only transmit your personal data to third parties if this is permitted by law or if you have expressly consented. Recipients of your personal data may be primarily other doctors / psychotherapists, associations of statutory health insurance physicians, health

insurance companies, the medical service of the health insurance, medical associations and private medical clearing houses.

The transmission takes place mainly for the purpose of billing the services provided to you, to clarify medical questions arising from your insurance relationship. In individual cases, data is transmitted to other authorized recipients.

#### 4. STORAGE OF YOUR DATA:

I only keep your personal data for as long as necessary for the implementation of the treatment. Due to legal requirements, I am obliged to keep this data for at least 10 years after completion of the treatment. According to other regulations, longer retention periods may result, for example 30 years for X-ray records according to paragraph 28 paragraph 3 of the X-ray Ordinance.

#### 5. YOUR RIGHTS:

You have the right to obtain information about your personal data. You can also request the correction of incorrect data. In addition, under certain conditions, you have the right to delete data and the right to restriction of data processing as well as the right to data portability.

The processing of your data is based on legal regulations. Only in exceptional cases do I need your consent. In these cases, you have the right to withdraw your consent for future processing. You also have the right to complain to the competent data protection supervisory authority if you believe that the processing of your personal data is not lawful.
